

## **Seed fees Review 2021-2022**

### **Purpose**

The purpose of this consultation is to seek views from individuals and companies including Professional Operators (seed merchants, seed processors, seed packers), Licensed Crop Inspectors, Licensed Seed Samplers, Licensed Seed Testing Stations (LSTS), farmers and interested members of the public on the Scottish Government's proposal to:

- Amend fees for seed certification, seed testing & associated seed functions to allow full cost recovery

We are inviting responses to this consultation by Midnight 15th May 2022.

Any amendments made to fees will become effective from 1st July 2022.

### **Background**

The Scottish Government has five Scottish Statutory instruments which legislate for the marketing of agricultural seed crops:

- The Beet Seed (Scotland) (No 2) Regulations 2010
- The Cereal Seed (Scotland) Regulations 2005
- The Fodder Plant Seed (Scotland) Regulations 2005
- The Oil & Fibre Plant Seed (Scotland) Regulations 2004
- The Vegetable Seed Regulations 1993
- The Seed (Licensing and Enforcement etc.) (Scotland) Regulations 2016

Within Scottish Government, SASA and the Rural Payments Inspection Directorate (RPID) have responsibility for carrying out the technical and administrative work associated with seed certification including field inspection of crops, testing of seed and the training and examination of people who undertake these activities.

Scottish Government's policy objective is that the fees set for public services should be full cost recovery, to avoid unnecessary public expenditure. SASA are the Seed Certifying Authority for Scotland and they review the fees for seed testing, seed certification and associated functions annually to ensure that costs incurred, are met by those businesses which benefit directly from the services provided.

The Covid-19 pandemic necessitated changes to ways in which Scottish Government, SASA and RPID were able to carry out their work. Social distancing requiring fewer people to be in laboratories, for example, or a reduction in the requirement for certain functions. Changing levels of restrictions meant that throughout the year the way in which staff worked also changed. The impact of this fluctuation made it difficult to assess costs per function across a given timeframe, and as such no change was applied to fees in 2021.

### **Scope of Consultation**

The proposals set out in this consultation apply to Scotland only.

## **Fees outline**

### **1. Seed Lot Fees**

These fees relate to issuing an Official Certificate or a Breeders Confirmation in respect of a seed lot, certifying the seed to be -

- (1) of a Multiplication category
- (2) of a final generation category

The specific nature of these costs entail documentation processing (SDG4, SDG7 & SDG10) relating to seed lot applications, preparation and the issuing of official certificates along with invoicing costs. Certification Plot Control costs are also included in these fees.

*Total costs calculated were £52,180.05, with a total income of £70,775.78, equalling a recovery of 135.6%.*

### **2. Crop Entry Costs**

This includes fees per hectare for entering a seed crop into the certification scheme in Scotland, late application fees applicable in addition to crop entry fees.

- (1) Pre basic or Basic seed
- (2) Certified Seed, Certified Seed of 1st Generation, 2nd Generation or 3<sup>rd</sup> Generation.

The costing for this area includes documentation processing relating to crop entries, preparation and issue of inspection results and invoicing.

*Total costs calculated were £52,180.05, with a total income of £70,775.78, equalling a recovery of 135.6%.*

### **3. Fees for undertaking an official inspection in Scotland**

Specific Costs include time spent on preparing for, undertaking and completing inspections, Travel and Subsistence costs directly related to crop Inspections.

*Total costs calculated were 69,280.40, with a total income of £65,519.99, equalling a 94.5% recovery.*

Fees are also set for taking an official sample and for issue and printing of an official label these fees are based on the time recorded by SASA and RPID staff against these functions.

*Total costs calculated were £2800.45, with a total income of £1976.05%, equalling a 70.6% recovery.*

### **Total costs for Seed Certification**

The total costs amounted to £124,260.90, with a total income of £138,271.82, equalling a 111% cost recovery. As mentioned previously, the impact of the Covid-19 pandemic resulted in adjustments to ways of working. These cost calculations are based on the period

April 2020-March 2021, which saw strict restrictions put into place on multiple occasions. It is worth noting that in the period 2020-2021 there was a reduction in staff costs of approximately £24,000. As we return to business as usual, these costs will be reinstated and should therefore be considered for the upcoming certification 2022-23 season. Doing so would likely result in an under-recovery, and therefore it is proposed that an increase in seed certification fees is made.

### **Official Seed Testing Station for Scotland (OSTS) fees**

The OSTs offers a wide range of laboratory tests that provide practical and reliable information for seed processors, merchants and growers on the quality of seed intended for sowing. Fees for OSTs functions do not appear in The Seed (Fees) (Scotland) Regulations, however they are reviewed in line with other certification costs.

For seed testing relating to certification the total recovery equalled 103%, indicating a slight over-recovery (costs were £213,424.00 and income was £220,214.00). However, as with the seed certification costs detailed in the previous section, a return to business as usual will likely have an impact on staff costs, therefore it is proposed that an increase in seed testing fees is made.

### **Licensed Seed Testing Stations and Seed Sampling Courses**

Schedule 2 of The Seed (Fees) (Scotland) Regulations addresses fees associated with making a representation, licence costs for licensed seed testing stations, and inspection and sampling courses. The past two years have impacted this area also, necessitating changes to a virtual or hybrid way of delivering functions associated with them. Some of the changes made may become 'the norm' moving forward, however this will need thorough consideration by delivery teams. In light of the potential change in how these areas will progress it is proposed that the fees in Schedule 2 remain static, pending review in the next fees assessment.

### **Options for consideration**

#### **Option 1:** Increase fees in line with inflation

- This option would increase fees for all seed certification, seed testing & associated seed functions by 5.4%, in line with CPI as recorded by ONS for December 2021.

#### **Option 2:** Increase fees at a lower rate of 3% across all functions

- This option would increase fees for all seed certification, seed testing & associated seed functions by 3%. This is in recognition of both the high value for CPI and the increases faced in other aspects of business e.g. rising energy costs.

Please see annexes A-D for examples of the proposed changes to fees.

Scottish Ministers' preferred option is to implement a 3% increase in fees, recognising that there is a need to mitigate against a possible larger increase in next season fees (2023), but also that there are rising costs for other aspects of seed businesses.

## **Duration**

The consultation will run for a period of 12 weeks.
