NOTES FOR COMPLETION OF FORM PP1

IMPORTANT – Do not include potato crops on this form that are being entered into the Seed Potato Classification Scheme (SPCS). Seed potato crops, and ware crops being grown on seed production units, should be entered on the SPCS application forms **SPS1** that are issued to seed potato producers in April.

If the total area of potatoes you grow is less than 0.1 ha, or if you no longer grow potatoes, please return this form stating that position.

VARIETY – Enter the name of the variety.

AREA – Enter the size of the crop in hectares to one decimal place.

FID NUMBER – Enter the field identification number of the field where the crop is planted, not the GPS co-ordinates of the crop.

FARM CODE – Enter the number of the farm/holding for the farm on which the potatoes are being grown.

ORIGIN OF SEED – Crop ID Number – If the potatoes are planted from purchased seed potatoes classified in 2024, enter the 6-digit crop ID number that can be found on the official label that was used to seal the seed containers. If the potatoes planted were classified in your name in 2024, enter the 6-digit crop ID number from your Crop Inspection Report.

Farm Saved Seed (one year's direct progeny of classified seed potatoes) – You will have received a notification detailing all the ware crops you grew in 2024. Each of your 2024 ware crops has been assigned a 6-digit crop ID number. Enter this number if you have used farm saved seed.

Multiple Input Seed Stocks – If a crop is grown from more than one origin, enter all crop ID numbers. Two lines are provided but if more than two input seed stocks are used please use the next line.

It is essential that farm saved seed and bought in (classified) seed are listed as separate crops if you intend to retain any of the crop for planting in 2026.

Country of Origin (for Scottish seed leave this box blank) – enter the name of the country which classified the planted seed potatoes. This will be stated on the official label. If you are unable to identify the crop identification number on the label, please contact your local SGARE Area Office.

DATE PLANTING COMPLETED – Enter the date the crop was planted.

RETAINED – If you intend to retain potatoes from this crop to be used as farm saved seed please indicate this in the tick box.

This form should be submitted to spcsapp@sasa.gov.scot or SASA, SPCS Unit, Roddinglaw Road, Edinburgh, EH12 9FJ **no later than 28 days after the start of planting.**
